By clicking on I accept the agreement and then the Next button or by using the enclosed program, you are consenting to be bound by this agreement. If you do not agree to all of the terms of this agreement, click I do not accept the agreement and then click the Cancel button and the installation process will not continue.

1. License

By receiving and/or using this Carmel Vision (Software), you accept and agree to be bound by the following End User License Agreement.
